## Planning and Advanced Reservation of Capacity Agreement (PARCA)

## PARCA NOTICE - RESERVATION OF NTS EXIT CAPACITY FOR HIRWAUN POWER STATION

## 3rd AUGUST, 2018

Dear Industry Colleague,

In accordance with the Uniform Network Code, Section B, National Grid hereby publishes this notice to all interested industry parties.

On 6th December 2017 National Grid issued a notice with respect to the receipt of a competent Planning & Advanced Reservation of Capacity Agreement ("PARCA") application. The PARCA application was for National Transmission System ("NTS") exit capacity of between 12,900,000kWh/d & 28,380,000kWh/d in South Wales and West Midlands South (Region 4 in the Gas Ten Year Statement<sup>1</sup>). The indicative capacity Registration Date specified at the time was 1<sup>st</sup> October 2020.

On 29<sup>th</sup> May, 2018 National Grid issued a notice ("Hirwaun Power Station ExCS Informal Notice (including exit Substitution & Baseline Revision)"). The informal notice confirmed that the PARCA Phase 1 Works had been completed to meet a capacity requirement of 28,380,000 kWh/d for a capacity Registration Date of 1<sup>st</sup> October, 2020.

National Grid is issuing this notice to confirm the PARCA application progressed to Phase 2 on 2<sup>nd</sup> August 2018, and NTS exit capacity has been reserved as follows<sup>2</sup>;
