

**Planning and Advanced Reservation of Capacity Agreement (PARCA)**

**NOTICE: PARCA APPLICATION – NOTICE OF RESERVATION OF NTS EXIT CAPACITY**

**UPDATED – 26<sup>th</sup> May 2023**

Dear Industry Colleague,

In accordance with Uniform Network Code, Section B, we are issuing this notice to all interested parties.

On 6th December 2017, we issued a notice with respect to the receipt of a competent Planning & Advanced Reservation of Capacity Agreement (“PARCA”) application. The PARCA application was for National Transmission System (“NTS”) exit capacity of between 12,900,000 kWh/d and 28,380,000 kWh/d in South Wales and west Midlands South (Region 4 in the Gas Ten Year Statement<sup>1</sup>). The indicative capacity Registration Date specified at the time was 1<sup>st</sup> October 2020.

On 29th May 2018, we issued a notice (“Hirwaun Power Station ExCS Informal Notice (including exit Substitution & Baseline Revision)”). The informal notice confirmed that the PARCA Phase 1 Works had been completed to meet a capacity requirement of up to 28,380,000 kWh/d for a capacity Registration Date of 1<sup>st</sup> October 2020.

On 15<sup>th</sup> April 2019, we issued a notice (“Updated Notice of Reservation of NTS Exit Capacity”) to advise of amended Registration Date of 1<sup>st</sup> October 2021.

On 7<sup>th</sup> April 2020, we issued a notice (“Updated Notice of Reservation of NTS Exit Capacity”) to advise of amended Registration Date of 1<sup>st</sup> October 2022.

On 28<sup>th</sup> April 2021, we issued a notice (“Updated Notice of Reservation of NTS Exit Capacity”) to advise of amended Registration Date of 1<sup>st</sup> October 2023.

We are issuing this notice to advise of a further amendment to the Registration Date as requested by the PARCA reservation party, as follows. The reserved Capacity Quantity is unchanged at 25,800,000 kWh/d.
